PAYMENT WILL BE MADE TO THE PAYEE IN THE CURRENCY OF THE COUNTRY TO WHICH REMITTANCE IS DIRECTED AT THE BUYING RATE OF THE BANK'S CORRESPONDENT FOR EXCHANGE IN NEW YORK, UNLESS THE REMITTER HAS REQUESTED THE BANK TO MAKE PAYMENT IN ACTUAL U. S. THE BANK SHALL NOT BE RESPONSIBLE FOR ANY LOSS OR DAMAGE RESULTING FROM ANY DELAY IN MAKING OR FAILURE TO MAKE PAYMENT BY REASON OF ANY LAWS, DECREES, ORDERS, OR REGULATIONS IN FORCE AT THE PLACE WHERE PAYMENT IS TO BE MADE, OR BY REASON OF ANY CIVIL, MILITARY OR WAR CONDITION OR OF ANY CAUSE BEYOND THE CONTROL OF THE BANK, ITS CORRESPONDENTS OR AGENTS OR SUB-AGENTS, OR ANY FOREIGN POST OFFICE. NOR SHALL THE BANK BE RESPONSIBLE FOR ANY DEFAULT, NEGLIGENCE OR MISFEASANCE OF ITS CORRESPONDENTS, AGENTS, SUB-AGENTS OR OF ANY FOREIGN POST OFFICE IN THE REMITTANCE OR PAYMENT OF THESE FUNDS IF THE BANK SHALL HAVE EXERCISED REASONABLE CARE IN THE SELECTION OF SUCH CORRESPONDENTS, AGENTS OR FOREIGN POST OFFICE. CABLE, TELEGRAPH, RADIO OR WIRELESS MESSAGES MAY BE USED AND MAY BE IN PLAIN LANGUAGE, CODE OR SPECIAL CIPHER, AND THE BANK SHALL NOT BE RESPONSIBLE FOR ANY LOSS OR DAMAGE RESULTING FROM THE USE THEREOF, OR FROM ANY DELAY, ERRORS, MUTILATIONS OR OMISSIONS IN THE MAIL OR ON THE PART OF ANY CABLE, TELEGRAPH OR WIRELESS COMPANY OR FROM CENSORSHIP LAW OR CONTROL, RIGHTFULLY OR WRONGFULLY EXERCISED, OF ANY DOMESTIC OR FOREIGN GOVERNMENT OR FROM ANY OTHER CAUSE BEYOND THE CONTROL OF THE BANK, ITS CORRESPONDENTS, AGENTS, SUB-AGENTS OR FOREIGN POST OFFICE. ALL THE RISKS HEREINABOVE SPECIFIED ARE ASSUMED BY THE REMITTER.

REFUND WILL BE MADE ONLY WHEN THE MONEY IS RECEIVED BY THE BANK IN NEW YORK CITY, BUT IN THE EVENT THE FUNDS HAVE BEEN CONVERTED BY THE BANK, ITS CORRESPONDENTS, AGENTS OR SUB-AGENTS, OR ANY FOREIGN POST OFFICE INTO FOREIGN CURRENCY, NO CLAIM CAN BE MADE AGAINST THIS BANK UNDER THIS TRANSACTION FOR ANY SUM GREATER THAN THE EQUIVALENT OF SUCH FOREIGN CURRENCY AT THE RATE OF EXCHANGE PREVAILING IN NEW YORK CITY ON THE DAY WHEN SUCH FOREIGN MONEY IS RECEIVED BY THE BANK IN NEW YORK CITY, LESS ALL PROPER EXPENSES.
